# COUNCIL ON AMERICAN ISLAMIC RELATIONS

STATE OF WASHINGTON

The undersigned natural person of the age of eighteen (18) years or more acting as incorporators of the corporation under the Washington non-profit corporation act, hereby adopt the following Articles of Incorporation for such corporation:

#### **ARTICLE 1**

The name of the corporation is Council on American Islamic Relations.

#### **ARTICLE II**

The corporation is a non-profit corporation

#### ARTICLE III

The period of its duration is perpetual. The corporation shall operate as a religious and educational corporation.

#### **ARTICLE IV**

The Corporation is organized strictly and exclusively for public charity, religious, scientific, and educational purposes, including for such purposes, the making of distributions to organizations under Section 501 (c) (3) of the Internal Revenue Code of 1934 (or the corresponding provision of any future United Stated Internal Revenue Law.)

#### ARTICLE V

The street address of its initial registered office is 12733 Lake City Way, Seattle, WA 98125, and the name of the initial registered agent at such address AHMAD HASHEM.

#### ARTICLE VI

The number if directors constituting the initial Board of Directors is eleven (11), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the members or until their successors are selected and qualified are:

#### ARTICLE VII

No part of the net earnings of the corporation shall insure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### ARTICLE VIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 510 (c) (3) of the Internal Revenue Core, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
